## Summary of proceedings of the 32<sup>nd</sup> Annual General Meeting

The 32<sup>nd</sup> Annual General Meeting ("AGM"/"Meeting") of Rose Merc Limited ("the Company") was held today, i.e., September 30, 2016, at 1.00 P.M. at the registered office of the Company situated at Office No. 5, Mangaldeep Chs, Sector - 4, Kalamboli, Navi Mumbai, Mumbai City – 410 218.

Mr. Viren Vora chaired the Meeting. After declaring the quorum being present, the Chairman called the Meeting to order.

With the consent of the shareholders, the Notice convening the Meeting and the Auditors' Report were taken as read.

Then after, Mr. Viren Vora, Director, made a presentation on various matters like the operations and financials for Financial Year 2015-16 and future prospects of the Company.

The Chairman then informed the Members that in compliance with the provisions of the Companies Act, 2013 and the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, ("the Listing Regulations"), the Company has provided to Members the facility to exercise their vote through remote electronic means. Further, the Chairman informed the Members that the facility of physical voting through ballot papers was made available at the venue of the Meeting for the Members who had not exercised their vote earlier.

He also informed that the Board had appointed Mr. Anand Lavingia, Practicing Company Secretary, as Scrutinizer to scrutinize the remote e-voting process as well as voting at the AGM in a fair and transparent manner.

Then after, the Chairman then read out the business to be transacted at the Meeting. As per Notice dated September 5, 2016, convening the 32<sup>nd</sup> AGM of the Company, the following business was transacted at the Meeting:

1. To receive, consider and adopt audited financial statement of account for the financial year ended on March 31, 2016 and the reports of the Director's and the Auditor's thereon;
2. To appoint a Director in place of Mr. Viren Chamanlal Vora (DIN: 01446499), Director of the Company, who retires by rotation and being eligible, seeks re-appointment;
3. Ratification of Appointment of Statutory Auditors and fix their remuneration;
4. Appointment of Mrs. Shakuntla Devendra Shah as an Independent Director of the Company;
5. Authority to the Board of Directors to borrow monies;
6. Authority for Creation of Charge / Mortgage on Property of the Company;
7. To make investment in excess of limit prescribed under Section 186 of the Companies Act, 2013.
